### WHY ENDOWMENTS? AN INVESTMENT FOR THE FUTURE!

#### hat is an Endowment?

An endowment is a donation of money, property or other financial assets to a non-profit organization which uses the resulting investment income for a specific purpose. Endowment funds are permanent in nature and are designed to keep the principal amount intact while using the investment income for charitable endeavors. Why have Endowment Funds?

Endowment funds create an ongoing source of income. Because endowment funds are invested in a pool of money which provides a reliable and endless source of income, the benefitting organization can count on annual distributions for its charitable work. An endowment fund holds its principal in perpetuity and only pays out a small portion annually, generally about 4 to 5 percent per year.

Endowment investments have dual goals: to grow the principal and to generate income. Endowments can also grow over time with additional gifts from multiple donors. Endowments established with the Oklahoma Disciples Foundation (ODF) provide an opportunity for churches and individuals to leave memorial legacies to benefit the future of the Oklahoma Region, local church or Disciples-related programs or missions. Annual distributions are only made to non-profit 501(c)(3) entities.

The Foundation holds nearly 100 endowment funds which provide annual funding for various areas of the Christian Church in Oklahoma (CCIO) as well as for congregations, institutions and missions related to the church including funds for the future of the Foundation. Many of these funds are named after Disciples individuals or churches as memorial legacies. Prior to final closing worship services, several Disciples church congregations made decisions to establish memorial legacy endowments to benefit programs and missions they wanted to support well into the future. Funding for these endowments came from the sale of church property and buildings as well as other church assets.

### Who can establish Endowment Funds?

Anyone can establish an endowment fund at ODF with a minimum gift of \$10,000 and by completing and signing an endowment agreement naming the fund and designating the beneficiary. It is also recommended that provisions be made to determine where or how future distributions should be made if the such beneficiary no longer remains a viable non-profit entity related to the church. ## WE REMEMBER JIM PRICHARD

James Parker "Jim" Prichard, age 85, passed away November 22, 2018, in Colorado Springs, Colorado following a brief illness. Born November 1, 1933, in Pampa, Texas to Sherman Parker and Carol Virginia (Corbett) Prichard, Jim was raised in Texas. He received a Bachelor of Science Degree in Mathematics from Texas Tech University in 1959. He lived in Oklahoma

for 40 years before relocating to Colorado in 2002. In early 1990, Jim was called by Reverend Gene Frazier, Regional Minister of the Christian Church (Disciples of Christ) in Oklahoma (CCIO), to join the regional staff as Director of Stewardship and Development. With the blessing of Sam Howard, founder and major contributor to the Oklahoma Christian Foundation (OCF), Jim also served as Executive Director of the Foundation. Since inception of OCF, Sam had maintained handwritten financial records for

the Foundation with the help of Tulsa Trust Company which held most of the Foundation's assets.

Sam also had input in deciding the investments of the Foundation. However a change was necessary to update the record keeping process as well as provide additional transparency. Therefore, Jim created spreadsheets of the financial

"Sam and I met regularly at his office in Tulsa and with Tulsa Trust Company," wrote Jim. "Sam helped the Foundation's assets grow by offering matching grants to endowments such as the Oklahoma Christian Women's and Men's Fellowships."

According to Jim, Sam felt strongly that the OCF should not compete with the Christian Church Foundation. In other words, OCF endowments were to benefit the mission and ministry of the Oklahoma region.

Jim served in the same role on the Northeast Area Christian Church Foundation, previously established by Sam and Mary Howard. Jim worked closely with Sam and the Northeast Area Director to create spreadsheets of their financial information.

Sam indicated several times that he wished he had created just one Foundation. Later following his passing, Sam's wish was granted as the two Foundations were merged into one entity on January 1, 2002 – the Oklahoma Disciples Foundation.

"Sam and I enjoyed a great relationship over the six years I served on the regional staff of the Christian Church in Oklahoma," said Jim.
