A legacy is the story of someone's life, the things they did, places they went, goals they accomplished, their passions and more. Legacy is something a person leaves behind to be remembered by.

ODF ACCEPTS MANY FORMS OF GIFTS

While cash gifts are among the most common gifts made to charity, gifts of property can provide added tax benefits. A gift of land, stock, personal property or a business interest may enable you to sell your assets without paying capital gains tax. And, you may also receive a charitable income tax deduction to reduce your taxes in that year.

The following assets may be received by ODF; however, certain gifts or circumstances may require review by the gift committee and ODF Board. ODF accepts gifts of:

- Cash
- Unencumbered royalty and mineral interests
- Publicly traded, marketable securities or bonds
- Real estate, including homes, buildings and land
- Life insurance policies where ODF is named as the owner and 100% beneficiary of the policy
- Jewelry, artwork, collections, equipment, or other assets may be accepted with approval by the Gift Committee and Board.
